The effective functioning of the link arrangement between Delegating Regional Office (DRO) - Collaborating Regional Office (CRO) shall be the responsibility of the RPFCs Incharge of both these offices, who are expected to work in close co-ordination to ensure that the desired results in the claim settlement periodicity is achieved without any issues.

The ACCs of the Zones in respect of both DRO and CRO shall closely monitor the performance of the offices and facilitate proper implementation of the above work arrangement.

It shall be the responsibility of the DRO to ensure that the establishments mapped with the CRO have clean member and establishment data without any legacy issue e.g., pending reconciliation or cases of short balances, etc. so as to avoid any erroneous payments.

The work distribution and role mapping of the staff in the functionality shall be carried out by the Zonal ACCs as per the multi-location claim settlement SOP and Instruction Manual issued vide circular 09.06.2020 and 04.11.2020.
