Shri S. K. Aggarwal, ACC(CSD)/Member North Zone and Shri Mahesh Srivastava, A.P.F.C. Banking/Treasurer were on leave. They were granted leave for their absence.

At the outset, the Assistant Secretary, EPF Central Sports Promotion Board welcomed the President and all the members of the Committee followed by a formal introduction of all those present in the meeting.

Thereafter, the Assistant Secretary briefed the President on the genesis of Central Sports Promotion Board in the year 1984 by the Central Board of Trustees.

Subsequently, the agenda items were taken up for discussion and the deliberation are as detailed below:

ITEM NO. 1

Confirmation of Minutes of the 31st meeting of EPF Central Sports Promotion Board held on 26-4-2013.

It was informed that the minutes of the 31st meeting of EPF Central Sports Promotion Board held on 26-4-2013 circulated vide Office letter No. Sports/31st Annual Meeting/2013/1675 dated 10-5-2013. Since, no comments/suggestions have received, the minutes of the 31st meeting were confirmed.

ITEM NO. 2

Action taken report on the decision of the last meeting held on 26-4-2013.

The Board was informed about the action taken on the decisions of the last meeting and intimated that all the Sports events planned for the year 2013-14 have been completed. The Board noted the same.

ITEM NO. 3

Report of the Secretary, EPF Central Sports Promotion Board on the Sports Activities as on 28-2-2014.

The Secretary, Central Sports Promotion Board presented the report. The EPF Central Sports Promotion Board noted the contents and expressed satisfaction on the work done in the field of Sports Activities. It was also brought to the knowledge of the

Board that the 32nd meeting of the Central Sports Promotion would be last one since the tenure of the present Board had expired and process of selection of new members was underway.

In the report, the Secretary brought forward the following important issues regarding administration of the Board in the time to come.

First issue that came for discussions was the need and the method for monitoring the Activities/working of the Regional Sports Promotion Boards. On this matter, the President desired that the Central Sports Promotion Board could devise a standard proforma for monitoring the activities of the respective Regional sports Promotion Boards.

The second issue related to designing of mechanism for regulating the cash flows between the Central Sports Promotion Board and the Regional Sports Promotion Boards. This was meant to avoid a huge amount lying idle in the accounts of Regional Sports Promotion Board.

The third issue was related to have a relook into the composition of the Central Sports Promotion Board, especially addressing the need for up gradation of the ex-officio Secretary in the light of recent changes due to cadre restructuring within the Organisation. The issue was deferred till the restructuring issue was settled.

The Secretary informed the Board that as the Sports events of the EPFO were repetitive in nature, therefore, the future Roadmap for the year 2014-15 would be as under:

- Only two events Football and Cricket would be conducted and in the year 2015-16, rest of the events would be conducted, based on which Sports Calendar at item No. 6 was placed.
- Athletic event was proposed to be conducted once in every four years.
- Review the teams competitive standard of the team be revised and only allow the players who fulfill minimum standard.

- The Sports Quota candidates appointed for particular sports need to be identify.
- Selection of the EPF National Team be done on the basis of identified Sports/Sportsmen.
- No players in the National Team would be selected beyond 40 years of age except in individual games.
- Instead of sending Regional team, Zonal Team should be allowed.

During the debate on the Secretary report, the president desired that instead of repetitive games every year, there was a need to have YOGA Courses in 10-20 Offices in the first phase.

The President also desired that there was a need for 3rd Party evaluation on the Sports Activities.

The President further desired to have the profile of each Sports Quota Employee so as to know the achievement of the Sports Quota Employees.

It was further emphasized that there was need to have <u>Run for Fun with</u>
<u>Employers and Employees on any given date.</u>

F.A. & CAO, however, stated that instead of having Athletic event after every four years, it would be better to conduct the Athletic event in two years and Indoor games could be conducted in Regional levels only. Chairman desired that this suggestion be examined separately on file.

R.P.F.C. (ASD) suggested that expenditure on Travelling Expenses should also be indicated along with total expenditure on Sports Activities. The President desired that information may be sought from the Regional Offices about the expenses incurred on Travelling Allowance on account of Sports Activities so that complete figure can be known about the total expenditure on Sports.

Note on Receipt & Payment Account for the year 2012-2013.

The Assistant Secretary presented the Receipt and Payment Account statement before the Board. The Board adopted and approved the Receipt & Payment Account for the year 2012-13.
