**(a) & (b): Contract workers are already under the ambit of Employees' Provident Funds & Miscellaneous Provisions Act, 1952. The definition of employee under Section 2(f) of the Act states that any person employed by or through a contractor in or in connection with the work of the establishment comes within the definition of "employee".**

**EPFO INVESTMENTS IN STOCK MARKETS**

**353. SHRI T. RATHINAVEL:**

**Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:**

- (a) whether it is a fact that a return of 1.57 per cent on the Employees' Provident Fund Organisation (EPFO) investment of Rs. 6577 crore, about 65 per cent of the total EPF amount in Exchange Trade Funds in the stock markets, was positive;**
- (b) whether it is also a fact that the EPFO is considering to enhance the percentage of investments in the market;**
- (c) whether it is also a fact that the EPFO is considering to invest in other avenues as well; and**
- (d) if so, the details thereof?**

**(a): Absolute return on Exchange Traded Fund (ETF) investment of Rs. 6,577 crore by Employees' Provident Fund Organisation (EPFO) as on 31<sup>st</sup> March, 2016 was 1.57 per cent. However, the absolute return on ETF investment of Rs. 7,468 crore as on 30<sup>th</sup> June, 2016 by EPFO was 7.45 per cent.**

**(b) to (d): As per the pattern of Investment dated 23<sup>rd</sup> April, 2015 notified by Ministry of Labour & Employment, investment in equity and related investments is permitted from 5 to 15 per cent. However, the Central Board of Trustees (CBT), Employees' Provident Fund (EPF) has approved investment of only 5 per cent in ETFs. At present, there is no proposal under consideration of the Government to enhance this limit.**

**Regarding investment in other avenues, investment is made by EPFO as per the pattern of Investment dated 23<sup>rd</sup> April, 2015 notified by Ministry of Labour & Employment.**

**(a) & (b): Monitoring and review of investments made by Employees' Provident Fund Organisation (EPFO) in Exchange Traded Funds (ETFs) is done by Central Board of Trustees (CBT), Employees' Provident Fund (EPF) from time to time. The absolute return on ETFs investment of Rs. 7,468 crores as on 30<sup>th</sup> June, 2016 by EPFO was 7.45 per cent.**

**(c): The CBT, EPF in its 207<sup>th</sup> meeting held on 31.03.2015 decided to invest up to 5 per cent of its total corpus in ETFs. A sum of Rs. 6,577 crore was invested in 2015-16. In 2016-17 also, 5 per cent of its incremental funds is to be invested by EPFO in accordance with the decision of 207<sup>th</sup> meeting of CBT.**

**(a) to (d): A new Scheme "Pradhan Mantri Rojgar Protsahan Yojana" has been announced in the Budget for 2016-17 with the objective of promoting employment generation and an allocation of Rs. 1000 crores has been made. The scheme is being implemented by the Ministry of Labour and Employment in 2016-17. Under the scheme employers would be provided an incentive for enhancing employment by reimbursement of the 8.33% EPS contribution made by the employer in respect of new employment.**

**The PMRPY scheme is targeted for workers earning wages less than Rs. 15,000/- per month. For the purpose of the scheme, a new employee is one who has not been working elsewhere on a regular basis prior to 1<sup>st</sup> April, 2016 and has a new Aadhaar seeded Universal Account Number (UAN) on or after 01.04.2016.**

- (a) whether workers engaged in unorganised sector are not reaping benefits of social security schemes in comparison to workers in organised sector, if so, names of such social security schemes along with number of organised and unorganised sector workers getting benefits of said schemes, details thereof;**
- (b) total number of workers of organized sector who are reaping benefits of EPF in the country, whether Government is contemplating to extend facility of EPF to workers of unorganised sector also; and**
- (c) if so, number of workers likely to be benefited from this and by when it would be implemented the details thereof?**

**(a) to (c): In Order to provide social security benefits to the workers in the unorganised sector, the Government has enacted the Unorganised Workers' Social Security Act, 2008. The 2008 Act provides for registration of unorganised workers and issuance of portable smart card by District Administration to them. Further, the 2008 Act stipulates formulation of suitable welfare schemes for unorganised workers on matters relating to: (i) life and disability cover, (ii) health and maternity benefits, (iii) old age protection and (iv) any other benefit as may be determined by the Central Government through the National Social Security Board. Various Schemes, formulated by the Government to provide social security cover to the unorganized workers, listed in the Schedule I of the above Act are as under:**

- i. Indira Gandhi National Old Age Pension Scheme. (Ministry of Rural Development)**
- ii. National Family Benefit Scheme. (Ministry of Rural Development)**
- iii. Janani Suraksha Yojana. (Ministry of Health and Family Welfare)**
- iv. Handloom Weavers' Comprehensive Welfare Scheme. (Ministry of Textiles)**
- v. Handicraft Artisans' Comprehensive Welfare Scheme. (Ministry of Textiles)**
- vi. Pension to Master Craft Persons. (Ministry of Textiles)**
- vii. National Scheme for Welfare of Fishermen and Training and Extension. (Department of Animal Husbandry, Dairying & Fisheries)**
- viii. Aam Admi Bima Yojana. (Department of Financial Services)**
- ix. Rashtriya Swasthya Bima Yojana. (Ministry of Health and Family Welfare)**

**The unorganised workers are getting benefits according to their eligibility for each social security scheme.**

**Average contributing member of EPFO during the Financial Year 2015-16 is 376.23 lakh. There is no proposal to extend facility of EPF to workers of unorganised sector.**

- (a): The State-wise details of average contributing members of Employees' Provident Fund (EPF) during the year 2015-16 are at Annex.**
- (b): As per Employees' Provident Funds & Miscellaneous Provisions (EPF & MP) Act, 1952, factories specified in scheduled I and establishments notified having 20 or more employees are entitled to be covered. Based on available information any establishment which is determined as entitled for coverage, would be covered. As such, the statistics of estimated number of workers and establishments entitled to be covered under the Act, but not actually covered is not feasible to be maintained.**
- (c): The following actions are taken by Employees' Provident Fund Organisation (EPFO) for coverage of all entitled workers and establishments under EPF & MP Act, 1952:**

- i. Inspections are conducted under Section 13 of the Act to ascertain whether an establishment has complied with the provisions of the Act.**
- ii. Action under Section 7A of the Act against the defaulting establishments for assessment of dues.**
- iii. Data of coverable establishments are collected by the Central Analysis & Intelligence Unit (CA&IU) of EPFO regarding Engineering Colleges, Dental Colleges, Medical Colleges, Spices Establishments, Coffee Exporters, private universities, National Rural Health Mission, etc. and conveyed to field offices to cover coverable establishments.**
- iv. Recovery actions including attachment of property and arrest as provided under Section 8B to 8G of the Act.**
- v. Action under Section 14 of the Act for filing prosecution against the defaulters before the competent court of law.**
- vi. Action under Section 406 read with Section 409 of Indian Penal Code (IPC) against the employer for non-payment of employees' share of contribution deducted from the wages/salary of the employees but not deposited in the fund.**

**Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:**

- (a) whether it is a fact that a large number of workers from the unorganised sector are not covered under the Employees' Provident Fund Organisation (EPFO);**
- (b) if so, the details thereof and the reasons therefor;**
- (c) whether Government is also considering to bring contract labourers under EPFO ambit;**
- (d) if so, the details thereof indicating by when it will happen; and**
- (e) the details of steps taken or proposed to be taken by Government for the enrolments in the EPFO scheme in the country?**

**MINISTER OF STATE (IC) FOR LABOUR AND EMPLOYMENT  
(SHRI BANDARU DATTATREYA)**

**(a) & (b): The provisions of EPF & MP Act, 1952 apply to every establishment which employs 20 or more persons and which is either engaged in an industry specified in Schedule-1 to the Act or belongs to a class of establishment specified by the Central Government. The industries/classes of establishments to which the Act applies include the following classes that are generally considered to fall under unorganized sector:**

- Beedi industry**
- Brick industry**
- Building and Construction Industry**

**Contd..2/-**

**The workers working in establishments employing less than 20 employees or workers working in an establishment, which is neither listed in Schedule-I of the Act nor in the classes of establishments specified by the Government, are not covered under EPFO. For the workers of unorganized sector, there is separate legislation viz. Unorganized workers' Social Security Act, 2008.**

**(c) to (e): The workers employed by or through a contractor in or in connection with the work of an establishment covered under EPF & MP Act, 1952, come under the ambit of EPFO in accordance with the definition of employee given in Section 2(f) of the Act. Sub-Committee of Central Board of Trustees on contract workers is constituted for monitoring the enrolment of contract workers. EPFO developed web portal of principal employer where the employer uploads the details of contractors. On the basis of these details the concerned EPFO, Regional/Sub-Regional Offices will watch and secure the contract workers compliance.**

The scheme is being implemented by the Ministry of Labour and Employment and employers would be provided an incentive for enhancing employment, where the Government will be paying the employers contribution of 8.33% towards the Employees Pension Scheme (EPS) in respect of new employment for 3 years.**

**The PMRPY scheme is targeted for workers earning wages upto Rs. 15,000/- per month. For the purpose of the scheme, a new employee is one who has not been working elsewhere on a regular basis prior to 1<sup>st</sup> April, 2016. Publicity and awareness campaign is an integral component of the PMRPY scheme for encouraging employers including Micro, Small & Medium Enterprises (MSMEs) to avail benefits.**
