## **GUIDELINES FOR VISUALLY IMPAIRED CANDIDATES**

Those candidates who are blind / low vision can use services of a Passage Reader of their choice during the Data Entry Skill Test. In all such cases where a Passage Reader is used, the following rules will apply:

- \* Only those candidates who had opted for and used Scribe during the Written Examination and were eligible to use Scribe in the Written Examination as per Government of India Rules governing the recruitment of Physically Challenged are allowed the services of a Passage Reader.
- The candidate will have to arrange his/her own Passage Reader at his/her own cost.
- The Passage Reader can be from any academic discipline.
- \* Both, the candidate as well as the Passage Reader will have to give a suitable undertaking, in the prescribed format with passport size photograph of the Passage Reader, confirming that the Passage Reader fulfils all the stipulated eligibility criteria for a Passage Reader as mentioned above. Further, in case it later transpires that he did not fulfill any of the laid-down eligibility criteria or suppressed material facts, the candidature of the applicant will stand cancelled, irrespective of the result of the skill test.
- \* Candidate who use a Passage Reader shall be eligible for compensatory time of 10 minutes, that means time allotted to them for skill test will be 20 minutes.
- \* The Passage Reader will only read the passage and typing will be done by the candidate. Passage Reader will not point out any mistakes/corrections to be made in the typing done by the candidate.
- \* The Candidate should ensure that he/she is fully conversant with the procedure of the Data Entry Skill Test as per details given on the website <a href="https://www.epfindia.gov.in">www.epfindia.gov.in</a>
- \* Under no circumstances shall the Passage Reader touch the Key Board at any time. All the Data Entry shall be done by the Candidate himself / herself.
- No extra time apart from the time provided shall be granted to the Candidate in the Data entry Skill Test.
