ORDER:

In the Government Order 1st read above, the Government have issued orders for granting exemption under section 17 (1) (a) of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 to M/s.Bapalal & Co., Jewellers Madras-86, subject to certain conditions specified therein.

- 2. In the Government Order 2nd read above, orders have been issued with the revised terms and conditions for exemption granted under section 17 (1) (a) of the above said Act, to M/s.Bapalal & Co., Jewellers Chennai-86.
- 3. In the reference 3rd read above, the Additional Central Provident Fund Commissioner (Exemption), Employees Provident Fund Organisation, Ministry of Labour and Employment, Government of India, New Delhi has stated that the Central Board of Trustees have resolved to surrender the exemption granted to the said establishment, due to some administrative reasons.

- 4. In the reference 4th read above, the Regional Provident Fund Commissioner-I, Chennai (South) has also stated that, as envisaged under section 17 (5) of the said Act, read with paragraph 28 of the Employees Provident Fund Scheme, 1952, the establishment had already transferred the entire past accumulation standing to the credit of all the members of the exempted trust "M/s.Bapalal & Co., Another Employees Provident Fund" in favour of the Central Board of Trustees, Employees' Provident Fund Organisation. Further, he has requested that as per the recommendations of the "Exempted Establishments Committee" as well as the "Central Board of Trustees" of the Employees Provident Fund Organisation communicated the cancellation of Exemption granted to M/s.Bapalal & Co., Jewellers may be notified under section 17 (4) of the Employees' Provident Funds and Miscellaneous Provisions Act, 1952.
- 5. The Government, after careful consideration accept the recommendation of the Regional Provident Fund Commissioner, Chennai (South).
- 6. Accordingly, in exercise of the powers conferred by sub-section (4) of section 17 of the Employees' Provident Funds and miscellaneous Provisions Act, 1952 (Central Act XIX of 1952), the Government hereby cancel the exemption granted to M/s.Bapalal & Co., Jewellers. Chennai-86 (TN.2562) vide G.O.(Ms.) No.4305, Industries, Labour, Co-operation Department, Dated 04.09.1964, with effect from 01.03.2011.
