Explanatory Note

(This does not form part of the Notification, but is intended to indicate its general purport.)

The Additional Central Provident Fund Commissioner, (Exemption), Employees' Provident Fund Organisation, Head Office, New Delhi has recommended to the Government to cancel the exemption granted to M/s Fertilisers and Chemicals Travancore Limited, Cochin Division on the grounds specified under condition 25 in Appendix A of para 27AA of the Employees' Provident Funds Schme, 1952. The Government have examined the matter in detail and have decided to cancel the exemption granted to M/s Fertilisers and Chemicals Travancore Limited, Cochin Division bearing code No.KR/KCH/3805 under para 27A of the Employees' Provident Funds Scheme, 1952.

The notification is intended to achieve the above object.
