Sub: Promotion to the post of Regional P.F. Commissioner-I in Level 12 of pay matrix on adhoc basis-reg.

On recommendation of Departmental Promotion Committee meeting held on 12.02.2025, for promotion to the post of Regional P.F. Commissioner-I, the Hon'ble Chairman, CBT, EPF is pleased to approve the appointment of the Shri Rajarshi Chakma, RPFC-II to the post of Regional P.F. Commissioner-I in Level 12 of pay matrix on adhoc basis for the Panel Year 2025.

- 2. On adhoc promotion, the place of posting of the officer upon promotion will be at RO, Bhubaneshwar as per order no. HRM-I/T-1(1)2025/Part-I/611 dated 27/03/2025. The adhoc promotion shall be effective from the date of assumption of charge.
- 3. The promotion shall be on ad-hoc basis against the vacancies available on account of sealed cover cases, till the sealed cover cases are finalized or regular vacancies in the grade arise, whichever is earlier. In case any officer whose recommendation is under sealed cover is exonerated and the sealed cover is opened and the officer is found FIT for promotion, he is given priority in promotion, if any and the junior-most officer shall be reverted if no vacancy exists to make place for this officer.
- 4. The officer can opt for fixation of pay within a period of 1 month from the date of assumption of charge as Regional P.F. Commissioner-I on ad-hoc basis.
- 5. The appointment would be without prejudice to the seniority and claim for promotion on regular basis of all other eligible officer and it shall neither confer on them any right to claim for promotion on regular basis, nor seniority.
- 6. The joining report of the officer as Regional P.F. Commissioner-I shall be forwarded to HRM, Head Office through Email to rc1.hrm@epfindia.gov.in. Further, the same shall also be updated on HR-Soft Portal.

7. The promotion of the above mentioned officer is subject to the outcome of the OA No. 435/2021 (related MA) filed before Hon'ble CAT, Patna and CP No. 19/2024 filed before the Hon'ble CAT, Patna bench.
